Changes to Grading Policy and Procedures & Rules for State Championships, State Age Championships, Night Interdistrict and Association Carnivals

MOVED: Blue Mountains Seconded: N. Matthews OAM (Life Member) that motions 1 through to 7 be put to the meeting together.

1. **MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 1.1 of the General Procedures be amended as follows:

1.1 Except for Rule 1.2 and 1.3 only Netball NSW affiliated Associations are eligible to enter competitions or events conducted by Netball NSW.

CARRIED 69:2 (Voting power 77)

- 2. MOVED: Board of Directors Seconded: Board of Directors that Rule 1.2 of the General Procedures be added as follows:
 - 1.2 Any grouping of Netball NSW affiliated Association can be admitted to enter the Competition subject to approval of Netball NSW. For the purpose of these Rules, Association means Netball NSW affiliated Associations and any other teams admitted to the various competitions in accordance with Rule 1.3.

Discussion:

- Sutherland: Requested definition of "grouping"
 - President: Detailed examples of Sapphire Coast and Hunter United groupings, which have both been in place for some time. Groupings generally approved by Council.
- L. Quinn OAM (Life Member): Could have a situation where groups apply that do not have an affiliated Association attached.
 - W. Archer AM, President: Is that not covered by subsequent wording subject to approval of NNSW?
- L. Quinn OAM (Life Member): Sapphire Coast is affiliated but doesn't run normal competitions, 4 or 5 clubs run competitions. If 3 or 4 of those groups got together they could put proposal to Board, Board approves and they could play without affiliation.
 - President: Clarified that question was whether a group of netballers, who are not affiliated, may enter. We need the capability to admit players who are not affiliated. The words "subject to approval of NNSW" is the overriding checkpoint.
- Sutherland: If groupings are approved by council, what conditions would be in place to stop a megagroup being created for competition purposes?
 - President: Need to apply some common sense to discussion. Most competition entries are subject to approval of NNSW or the Board, gave example of Premier League group. Council charges the Board with responsibility to allow or disallow entries and flexibility is needed.
- Shoalhaven: Requested motion be put, we wish to form a group.

 - 1.3 Netball NSW may admit teams to various competitions on an invitation basis as required. Invitational teams will be charged a Netball NSW invitational fee of two hundred dollars (\$200.00) in addition to the Competition entry fee to enter the competition.

- 7. MOVED: Board of Directors Seconded: Board of Directors that Rule 1.10 of the General Procedures be amended as follows:
 - 1.12 Where an Entity withdraws a team from any Netball NSW competition within three (3) weeks of the commencement of the particular competition the offending body will be fined \$500.00. CARRIED 73:0

- 8. MOVED: Board of Directors Seconded: Board of Directors that Rule 1.13 of the General Procedures be added as follows:
 - 1.13 Where an Association is not satisfied with a decision made by Netball NSW under this policy, an Association may lodge an appeal. An Association can only lodge an appeal regarding a decision made which directly affects that Association. An association cannot lodge an appeal for or on behalf of another Association or Associations. Such appeals are to be undertaken in accordance with the Appeals Tribunal Procedures set out in Clause 5 of Attachment E Hearings and Appeals Tribunal Procedural Requirements of the Netball NSW Member Protection Policy (or in accordance with the netball NSW Member Protection Policy as amended from time to time). The decision of the Appeals Tribunal is final and binding on the parties.
- **9. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 2.6 of the Grading Procedure for Region 1 Night Inter District be added as follows:
 - 2.6 The minimum age for any player to play in the Night Inter District Competition is turning 14 in the year of play.
- **10. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 2.6 of the Grading Procedure for Region 1 Night Inter District be amended as follows:
 - 2.7 All grading shall be based on names submitted on the official entry forms and taking into account a players highest level played in the same year across competitions such as:
 - Premier League;
 - Metro League;
 - State Championships;
 - State Age Championships;
 - Night Interdistrict; and

all grading of teams will be made at the discretion of Netball NSW. Ladder positions of the previous season are not used for grading purposes in NID.

- MOVED: Board of Directors Seconded: Board of Directors that Rule 2.8 of the Grading Procedure for Region 1 Night Inter District be deleted:
- **12. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 2.9 of the Grading Procedure for Region 1 Night Inter District be amended as follows:
 - 2.9 For NID Netball NSW will, based on the number of entries received be responsible for determining the format of the competition
- **13. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 3.2 of the Playing Rules for Region 1 Night Inter District be added as follows:
 - 3.2 The Night Interdistrict Competition is a sporting activity for female players only.
- **14. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 3.5 of the Playing Rules for Region 1 Night Inter District be amended as follows:
 - 3.8 Each team will be allowed only one (1)forfeit throughout the competition without penalty. On the second occasion the forfeiting team will be fined \$100.00. Each subsequent forfeit the fine will increase by \$100.00. A team that withdraws from the competition after the commencement will be classed as forfeiting each match after this date.
- **15. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 3.6 of the Playing Rules for Region 1 Night Inter District be amended as follows:
 - 3.9 Players may play up to two (2) matches in any given week subject to the following conditions:
 - a) Games must be in alternate time slots if played on the same night.
 - b) One game must be in the team in which the player is registered.
 - c) Additional game must be in a higher graded team from the same association as the player is currently registered in the NID Competition for.
- **16. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 3.11 of the Playing Rules for Region 1 Night Inter District be amended as follows:
 - 3.11 A maximum of four (4) players may be late registered in each team, late registrations will be accepted from one week before the commencement of the competition until the end of the NID competition.
- **17. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 3.13 of the Playing Rules for Region 1 Night Inter District be amended as follows:
 - 3.15 Late registrations are to be submitted on the appropriate form by an Association official to Netball NSW prior to the commencement of the match in which they are to play. The player must be a financial registered member of Netball NSW as shown in the MyNetball database.
- **18. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 3.14 of the Playing Rules for Region 1 Night Inter District be amended as follows:

- 3.16 After a team has been graded, any late registration should be of an equal playing standard. Netball NSW may reject a late registration where it considers the inclusion of the player would affect the grade of the team. In such circumstances the Association or player concerned has the right of appeal to the Appeals Tribunal, as detailed in clause 1.13.
- **19. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 3.15 of the Playing Rules for Region 1 Night Inter District be amended as follows:
 - 3.17 A player may only be a member of a Team in a maximum of two (2) divisions in one season. Where a player plays three (3) matches in a division higher than that originally graded, on playing the third game in the same higher graded team the player will transfer to that higher graded team for the remainder of the competition and cannot participate in any other game in any higher graded division for the remainder of the competition.
- **20. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 3.16 of the Playing Rules for Region 1 Night Inter District be amended as follows:
 - 3.18 If an Association records the name of an unregistered or ineligible player on the score sheet, the Association will be required to prove within seven (7) days that the person who played under that name is registered with that team.

This proof shall be in the form of a Statutory Declaration to Netball NSW. Failure to submit such proof within seven (7) days of notification shall result in the following penalty:

- a) The team playing the ineligible player will be considered to have lost the Competition match in which the ineligible player has taken part in.
- b) The points for winning the Competition match will be awarded to the opposing team (provided the opposing team itself has not played an ineligible player)
- c) The Team playing the ineligible player will lose two (2) competition points.
- **21. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 3.19 of the Playing Rules for Region 1 Night Inter District be amended as follows:
 - 3.21 Bench Officials
 - a) Each team is to provide up to two (2) approved Bench Officials who have completed the on line Bench Officials education course and the Netball NSW practical training workshop and hold a current certificate.
 - b) Where an Association fails to provide the appropriate number of approved Bench Officials a fine of \$50.00 will be imposed.
 - c) Netball NSW will remove any person who has not completed the on line Bench Officials education course and the Netball NSW practical training workshop from the bench and a fine of \$50.00 will be imposed on the offending Association.
- **22. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 3.20 of the Playing Rules for Region 1 Night Inter District be amended as follows:

3.22 Equipment

a) Scoresheets, will be supplied by Netball NSW and will be available for each match on the score bench.

- b) Each team is to provide an approved match ball.
- c) Each team is to have available two (2) sets of position patches of different colours.
- **23. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 3.21 of the Playing Rules for Region 1 Night Inter District be amended as follows:
 - 3.23 Score sheets shall be returned to central control at the conclusion of each match, by the winning team.
- **24. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 3.22 of the Playing Rules for Region 1 Night Inter District be amended as follows:
 - 3.24 When matches are cancelled due to an event which NNSW determines was beyond its control or beyond the control of either Team (including, but not limited to, a strike, power loss, wet weather that causes stadium or court damage or extreme weather conditions), the Match will be deemed to be a draw and each Team will receive one (1) competition point each. No points will be awarded for teams having a scheduled Bye. Where a team has already submitted a forfeit prior to the cancellation of matches, the forfeit will remain.
- **25. MOVED:** Board of Directors **Seconded:** Board of Directors that Rules 3.28 of the Playing Rules for Region 1 Night Inter District be deleted:
- **26. MOVED:** Board of Directors **Seconded:** Board of Directors that Rules 3.29 of the Playing Rules for Region 1 Night Inter District be deleted:
- **27. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 3.30 (e) of the Playing Rules for Region 1 Night Inter District be amended as follows:
 - 3.30 Umpires:
 - e) Umpires must be dressed in white.

- **28. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 4.3 of the Grading Procedures for State Age Championships be amended as follows:
 - 4.3 Where an age qualification applies, players are to play in their correct age group, unless special permission is granted. Any request for players to play in a higher age group than that for which they are eligible must be submitted on the designated form published on the Netball NSW website for approval prior to the Competition.

A maximum of 4 players per team are eligible to play in a higher age group.

Discussion:

- Nelson Bay: we would be adversely affected by minimum 4 players rule. For example, going into next year's competition we would have 4 to 5 players left in one age group (as other players have moved on) and would propose to move them up an age grade to 15/U team but this rule would mean that we lose two teams.
 - President: Could add in words at end of paragraph, "unless approved by NNSW".

- A. Doring OAM (Life Member): Suggested to retain former wording because, if it is necessary to put in more/less than 4 with NNSW approval, can't see need to change.
 - CEO: Intention of amendment is to streamline the process.
 - President: Proposed amendment makes process less complicated: Associations can play up to 4, and apply to NNSW to have more.
- Kiama: Suggestion addition of words "without approval of NNSW"
- Bankstown: Suggested removal of entire sentence about maximum of 4 players. Leave it the way it is.
 - President: My reading is that it allows up to 4 players without NNSW approval, more than that requires NNSW approval. Suggested amendment is to remove the clause "A maximum of 4 players per team eligible to play in higher age group." Intention being that if you want any players to play up (i.e. 1 or even 6 players) you ask NNSW for permission.

Motion 28 put with amendment of removal of words "A maximum of 4 players per team eligible to play in higher age group." CARRIED

- **29. MOVED:** Board of Directors **Seconded:** Board of Directors that Rule 4.4 of the Grading Procedures for State Age Championships be amended as follows:
 - 4.4 Associations are to register teams as directed by Netball NSW, the entry will include details of a minimum of seven (7) and a maximum of twelve (12) players' names and must include their relevant experience by the closing date for State Age.

CARRIED

30. Moved and seconded Campbelltown that Clause 4.5 of Grading Procedure for State Age Championships be amended as follows:

4.5 A final team list will consist of those players from the original registration form who are available to compete and up to a maximum of four (4) late registrations. This list shall be lodged with control by 8.00am of the first playing day of State Age and checked against original entry.

<u>Add</u>: Following submission of the final team list, any team with less than ten (10) players able to play due to injury or illness, may, after production of a medical certificate verifying same, register replacement players.

We also refer to Grading Procedures for State Age Championships, in particular Clause 4.8, which reads:

Entries will be graded into divisions, being Championship Division, Division 2, Division 3 and Division 4 according to the number of entries received. There will be 20 teams in Championship Division and the remaining entries will be divided as far as is possible equally between Division 2, Division 3 and Division 4.

Where more than 80 entries are received in an age group, 22 teams will be graded into the Championship Division for that age group. In the year of this increase in Championship Division, grading will be done with the two bottom teams being moved down to Division 2 and the 4 top teams moved up from Division 2 to Championship Division.

There were 82 teams entered in the 13 years at State Age, which meant that 22 should have been graded into the Championship Division and the remaining 60 teams divided equally between Division 2, Division 3 and Division 4.

However, the grading procedure was not followed. The bottom team in Championship Division was relegated to Division 2 but the team which finished 19th was not. With this team remaining in Championship Division and the number restricted to 21 teams rather than the 22 stipulated, the two teams which finished third and fourth in Division 2 were denied a game in Championship Division. As well as missing out on Championship Division, these teams were required to play three invitational teams, which meant they had 15 games against NSW members rather than the 21 they should have played in Championship. One would also query if the three top teams in Division 3 would have preferred to take the place of the invitational sides in Division 2.

Discussion:

- Campbelltown: Concerned because this year we had bad injury and virus issues, therefore concerned about duty of care: by day 3 we had 8 players.
 - President: Amendment would be suitable for metropolitan teams who can get players at short notice, it would disadvantage country Associations.
 - N. Horton (Head of Netball): A 3-day event has different circumstances to an 18 week competition.
- Bankstown: There is also a duty of care in that a player may not be ready to play at short notice.

- Campbelltown: Instead of being advised that Board has made amendment to a policy, could Council receive detail of the amendments made?
- Mens: Several State MPs have paid tribute in Parliament to netball luminaries Dot Lockwood, Hastings Valley Association and Jordan Kiss honoured by Scot Macdonald MLC, Vera Wiltshire posthumously honoured by David Clarke MLC, Clare McCabe honoured by Lou Amato MLC.
- Campbelltown: Noted that Dave Shorrocks had been appointed to Medical Panel of Commonwealth Games.

- Kiama: Requested that Netball Australia (NA) be invited to Council meeting.
 - President: More than happy to ask NA, we ensure that NNSW has representation on all NA workgroups.
- Orange: Future Leaders Forum, congratulations to Lauren Woods and NNSW a great weekend.
- Penrith: Fees: concerned from Association level that we are now going to keep putting our fees up, don't want to get to Council in 12 months and see 10% increase. How close are we to covering costs of competitions?
 - M. Anderson: Reducing reliance on capitation fees by increase in sponsorship. We hope those fees increases would lower in future.
 - President: May not wish to see sponsorship names everywhere in the competition. Understand that at Association level it is just as hard. Board is very aware of costs involved and increases we are asking. Still a reasonably big gap on some of our events breaking even, have carried loss for a very long time but can no longer afford to do so.
- Penrith: We will be losing players to AFL and Soccer because of netball fees increase. Can we bring increase back to CPI level rather than 10%?
 - President: Formerly we would hold fees for 4 5 years without increase then a significant increase; but Council said it didn't like that and would prefer incremental increases.
 - CEO: It has been in excess of 12 years since affiliation structure was changed. Some of the increase in costs includes governance, compliance and support of Associations. Always seeking ways to encourage netball consumers to join. We are not a sport that has top-down funding like AFL or Cricket, but we are lot better off than many other sports.
 - C. Feldmanis (Director): Board is very conscious of numbers and infiltration of AFL and NRL, particularly in Western Sydney. Endorsed CEO's comments that NNSW is striving to increase participation.
 - M. Baron-Hay (Director): Moving from a background in AFL, early impressions of netball include that it is a wonderful product with competitive advantages such as participation levels, world champions, best competition in the world. The future is what we make of it: don't see the problem, see the opportunity to capitalise on all those netball strengths. Currently grass roots subsidies the elite (the opposite of AFL). We have best elite competition in the world and in time the elites will subsidise grass roots. This will mean changes, commercialising/monetising the opportunity and broadcast rights.
- Gosford: Noted increased operation cost and competition fees: SSN forecast increase loss of \$200k to \$900k loss is our increase in fees subsidising that?
 - COO: for 2018 year we have looked at how we allocate wages, staff management cost allocation into that SSN area. Wages/staff costs not previously shown in that SSN area so that is the major reason for the differential. Revenues have increased, but insufficient to cover losses.
 - President: It is not intention that members subsidise NNSW we need this for our bench officials, coaches, umpires etc.
- President: Board has instigated a Nominations Panel, 3 elected members from Council and two Board members. On Monday/Tuesday this week an expression of interest in nominating for the Nominations Panel will be sent to Associations. Association Secretaries should send it out to anyone interested in being on that Panel. Board will provide matrix of what is required for Board's makeup.

President: If this motion is passed, our Governance Committee will go through requirements.

Election of Directors shall be by postal vote conducted by the Returning Officer as per the Election and Postal Voting Policy with the results announced by the Returning Officer at the Annual General Meeting each year.

Elected Directors will be elected on an alternating basis.

Four Elected Directors will be elected one year and three Elected Directors will be elected the next year.

At the 2018 AGM, the President and three Elected Directors will be elected; the President and the Elected Director with the highest vote will serve a three year term and the Elected Directors receiving the third and fourth highest vote will serve a two year term;

At the 2019 AGM, three Elected Directors will be elected; the two Elected Directors with the highest vote will serve a three year term and the Elected Director receiving the third highest vote will serve a two year term;

Mens: What is status of electronic voting?

President: Electronic voting will be in effect for AGM 2018. Once today's motions are completed, changes will be made to the voting policy.

Sutherland: Does Policy change Constitution, believe we should be amending Constitution first.

President: Policy itself is not in the Constitution, just the name of the policy.

Kiama: If 4 Directors elected in one year and 3 elected in second year, so no directors elected in year 3? President: this is only a transitional arrangement.


8.2 Finance Report



Finance Report For Council Meeting 24th March 2018 – Issued 2nd March 2018

The Netball NSW year to date profit figure for the period ending 31 January 2018 is **\$373,289** (before interest & other income, depreciation expense & extraordinary items). **Minimal P&L reforecasting has been completed at this early stage of the year and the full year forecast for 2017 is for a profit of \$98,387** (before interest & other income, depreciation expense & extraordinary items) against a budgeted profit figure of \$227,932.

The current net equity position of Netball NSW is **\$31.667M.**



Below graph show the revenue breakdown for the Company for the 2017 full year and includes a 2016 full year comparison.

At 31 January 2018 the expected year end cash position is \$1.845M against a budgeted end of year position of \$2.017M.

For further information please refer to the Consolidated Trading Statement and Balance Sheet.

Membership count as at 18th February 2018 was 60,647 members (count as at 18th February 2017 was 57,019). Capitation Revenue reforecast for 2018 is \$6.797M (includes NetSetGO!).

Netball NSW Membership numbers for the 2017 year were 113,356 (capitation revenue was \$6.607M).

8.3 CEO's Operational Report

In reflection of 2017 we are proud of the achievements by all involved in Netball NSW. The following report captures just a few of these achievements.
