Netball NSW Inclusive Community Grants 2020 Grant Application Terms and Conditions

Netball NSW Inclusive Community Grants ('Grants') are funded and administered by The New South Wales Netball Association Limited ('Netball NSW') (ABN 19 001 685 007). The Netball NSW Inclusive Community Grants Program ('Grants Program') is designed to demonstrate how netball can have a positive impact in communities across NSW. The award of Grants is subject to a number of terms and conditions and, by submitting a Netball NSW Inclusive Community Grants 2020 Application Form ('Application Form') to Netball NSW, grant applicants agree to comply with the following Grant Application Terms and Conditions:

- Applications are open to organisations and individuals that meet the criteria set out in the "Eligible Applicants" section of the Netball NSW Inclusive Community Grants 2020 Application Guidelines ('Application Guidelines'), which are available online at the Netball NSW Website;
- 2) If an application does not comply with these Grant Application Terms and Conditions and the Application Guidelines, it will be ruled invalid and withdrawn from consideration;
- 3) To apply for a Grant, applicants must accurately and truthfully complete an Application Form, which is available online at the Netball NSW Website;
- 4) To be considered for a Grant, an Application Form must be completed and submitted by the deadline set out in the Application Guidelines;
- 5) These Grant Application Terms and Conditions must to be read in conjunction with the Application Guidelines and any completed Application Form ('Application Documentation');
- 6) The Application Documentation, together with the Grant Terms and Conditions (which apply to successful grant applications), form the terms of the agreement that applies to Grants awarded under the Program;
- 7) As the number of applications may be substantial, not every application that meets the selection criteria will necessarily receive a Grant. All decisions relating to the award of Grants, including the amount of any Grant, will be guided by the objectives and criteria set out in the Application Guidelines, but remain subject to the absolute discretion of the Netball NSW Inclusive Community Grants Assessment Panel ('Grant Assessment Panel'). All applicants will be informed of the outcome of their application. By submitting an Application Form, applicants agree that the decisions of the Grant Assessment Panel will not be subject to any right of appeal;
- 8) By submitting an Application Form, all applicants (whether or not their applications are successful) consent to Netball NSW disclosing the information provided by those applicants for the purposes of reviewing, processing and awarding Grants and for any other purpose connected or incidental to Netball NSW's administration of the Program;
- 9) Applicants may be contacted by Netball NSW for the purposes of validating information and conducting due diligence in relation to applicants and their applications.
