



## ***Exemption under the Public Health (COVID-19 Restrictions on Gathering and Movement) Order (No 4) 2020***


under the *Public Health Act 2010 (NSW)*

I, Brad Hazzard, Minister for Health and Medical Research, under clause 24 of the *Public Health (COVID-19 Restrictions on Gathering and Movement) Order (No 4) 2020* hereby exempt a *Netball Association* from the operation of clause 17 of that Order subject to the conditions below:

- 1) Where the total number of people anticipated to attend the community sporting activity exceeds 500, a Netball Association must ensure that people are divided into discrete groups of no more than 500 persons.
- 2) There must be a physical barrier or, in the alternative, a distance of a minimum of 15 metres, separating each discrete group at the community sporting activity.
- 3) Only a person engaged by the Netball Association to provide services associated with the management of the community sporting activity can cross the barrier or physical distance referred to at clause (2).
- 4) A Netball Association must, if required to do so by NSW Health, provide to NSW Health the name and contact details of attendees at the community sporting activity in any manner determined by NSW Health.
- 5) A Netball Association must ensure, so far as is reasonably practicable, that spectators remain 1.5 metres from other attendees at all times.
- 6) A Netball Association must ensure, so far as is reasonably practicable, people do not attend a community sporting activity if they are ill with fever or any respiratory symptom (including cough, sore throat, or shortness of breath).
- 7) A Netball Association must, to the extent possible, limit the number of attendees at community sporting activity.
  - a. Without limiting cl.7, a Netball Association must, to the extent possible, seek to ensure that only one guardian or parent is to attend the community sporting activity per player.
- 8) The exemption only applies when a Netball Association listed in column 1 of Schedule 1 is organising a community sporting activity at the location specified in column 2 of Schedule 1.

A person who is participating in a community sporting activity run by a Netball Association in accordance with this exemption is exempt from clause 18 of the Order while participating in that activity, or immediately before or after that activity.

In this exemption, a *Netball Association* is an association listed in Column 1 of Schedule 1
