#### Introduction

In accordance with clauses 13.13 and 13.14 of the Netball NSW Constitution, the Annual General Meeting and first Council Meeting of the year will be held on Saturday 19 March 2022 as hybrid meetings.

Two separate meetings will be conducted starting with the Annual General Meeting, followed immediately by the Council Meeting.

Due to COVID-19 capacity restrictions and adherence to COVID-19 guidelines, the meetings will be held, in person, at the Tennis NSW Function Centre with the Board, a small number of selected Netball NSW officeholders, up to two Association Delegates per Association and Life Members in attendance and via ZOOM video conferencing for those Association Delegates and Life Members who are not able to attend in person.

Please note that voting instructions and access to Ballot materials for both the election of Elected Directors and for the award of Life Membership will be sent via email (or by post, if this delivery method has been requested) to all Association Presidents and Secretaries (unless an Association has nominated an alternative person prior), Life Members and Directors on Friday 4 March 2022. The ballot opens at 10.00am (AEDT) on Friday 4 March 2022, with voting closing at 5.00pm (AEDT) on Friday 18 March 2022.
