Dear Member Associations and Members,

Following an extensive review by Netball Australia and the State Member Organisations of the National Netball Insurance Program and our existing insurance broking and risk advisory services, a collective decision has been made to replace V-Insurance Brokers with Howden Insurance Brokers (Australia) Pty Ltd (Howden).

In practical terms, the move to Howden is effective Monday 9 October 2023 which enables sufficient time for the annual renewal of insurance policies for 2024. Further information will be provided to Member Associations and Clubs in due course regarding the renewal process, particularly in relation to property insurance (Industrial Special Risks policy). From the above date, Howden will be our exclusive insurance broker taking over the management of all existing insurance policies on the behalf of Netball New South Wales which provide a level of insurance cover for our member associations, clubs, participants, volunteers and staff.
