1 Definitions

Abandoned match means a Match or Matches that Netball NSW, in its absolute discretion, deem are unable to be continued or re-scheduled.

Affiliate Member means a body corporate that is affiliated with the Company through Netball and becomes a Voting Member in accordance with the Netball NSW Constitution and the relevant Company Policy.

Association and/or Affiliated Association means any Affiliate Member as defined in accordance with clause 9.3 of the Netball NSW Constitution and the relevant Netball NSW Affiliation and Membership Policy (as amended from time to time), where such application for affiliation has being approved by voting members.

Association Liaison Officer means a person nominated by the Association to act as the point of contact between Netball NSW and the Association during the competition.

Association Official means a person who represents an Association with the authority to act on behalf of the Association.

Competition means the Netball NSW Junior State Titles.

Competitions Manager means the person who has been appointed to the role of Competitions Manager with Netball NSW.

Competition Rules means the rules of the Competition as articulated within this document.

Divisions mean the competition divisions at the Junior State Titles called Championship Division, Division 2, Division 3 and Division 4.

Invitational Team means a Team that has requested to enter the Competition and has been approved to play in the Competition, but will not be eligible for a placing.

Match means any netball match or game, excluding training matches, played by or between Association Teams within the Competition.

Member Organisation means an organisation affiliated to Netball Australia, being the peak body for the game in their respective State or Territory.

Netball NSW (NNSW) means the New South Wales Netball Association Limited.

Player means any person who has a current financial registration with NNSW and who has been registered with the relevant Association Team.

State Titles Grading Review Panel means a panel of Netball NSW and Association Representatives convened to review submissions received from Associations to review pre-entry grading.

Team means each of the Associations netball Teams or Invitational Teams granted the right to compete in the Competition by Netball NSW.

Team List means the list of players registered to play in the Competition for an Association.

Team Officials mean officials involved with the management, preparation and participation of the Team, including the coaches, manager, doctor, physiotherapist and other support staff.

Umpire means an umpire appointed by Netball NSW to officiate in a Match.

2 Event Information

2.1 General Information

- 2.1.1 Subject to these Competition Rules and the Netball NSW Constitution, the Competitions Manager shall have the authority to investigate and adjudicate all questions and disputes arising out of the Competition. If a matter is not provided for in the Competition Rules and the Netball NSW Constitution, the Competitions Manager may make any determination they consider appropriate after consultation with the Netball NSW Executive General Manager Community and Pathways, and/or the Chief Executive Officer, where appropriate, and the decision shall be final.
- 2.1.2 The Netball NSW Junior State Titles are conducted under the authority of Netball New South Wales, in partnership with the Host Association.
- 2.1.3 The Netball NSW appointed Competitions Manager has the overall responsibility for the day to day operation and management of each Event.
- 2.1.4 Netball NSW will work with the Host Association to manage the format, structure and conduct of the event.
- 2.1.5 The Competitions Manager has the power to waive compliance with the Junior State Titles Competition Rules when satisfied that extenuating circumstances exist.
- 2.1.6 Any request to waive compliance with the Junior State Titles Competition rules must be submitted in writing and be addressed to the Competitions Manager or their appointed delegate.
- 2.1.7 Junior State Titles are conducted in the 14 years, 13 years and 12 years age groups.
- 2.1.8 All matches shall be played on all weather hard courts or a combination of indoor courts and all weather courts.
- 2.1.9 Netball NSW may at any time change any competition match procedure, format or venue, where it is deemed necessary to comply with any legislation, government regulation or order, including but not limited to those related to COVID-19.

2.2 Venues and dates

- 2.2.1 Junior State Titles are held on the first weekend of the second term school holidays, on the Saturday, Sunday and Monday.
- 2.2.2 Netball NSW appoints Netball NSW Affiliated Association venues to host the Junior State Titles (**Host Association**), with the overall management of the event falling under Netball NSW.
- 2.2.3 A minimum of two (2) venues may be used for the Junior State Titles.

2.3 Uniforms and Equipment

- 2.3.1 Players in an Association Team must play in matching playing uniform unless extenuating circumstances exist, in which case a letter of request must be sent to the Competitions Manager providing an explanation and giving as much notice as possible.

For the avoidance of doubt a matching uniform may be different styles, (dress, shorts and singlet), however the design (colours, patterns) must be matching across all pieces. Refer to the Netball NSW [Inclusive Uniform Guidelines](#).

- 2.3.2 Each Team is to have available two sets of position patches, of different colours.
- 2.3.3 Each Team is to provide an appropriate match ball, as per the Rules of Netball.
- 2.3.4 Associations may identify one sponsor logo on the playing uniform up to a maximum length of 16cm and maximum height 16cm. Sponsor logos may only appear once on the uniform per player.

2.4 Complaint Handling

- 2.4.1 All complaints lodged with Netball NSW in relation to the Competition will be dealt with in accordance with Netball NSW Complaints Handling Procedures.
- 2.4.2 All registered Players, Umpires, and Team Officials are required to abide by the Netball NSW Code of Behaviour.
- 2.4.3 All participants of the Competition including but not limited to Players, Umpires, Team Officials and Association Officials, who have breached the Code of Behaviour, Netball NSW Member Protection Policy and/or the Netball NSW Disciplinary Policy, may be subject to disciplinary action as listed within the corresponding policy.

3 Competition Structure

3.1 Eligibility

- 3.1.1 Except for clause 3.1.2, 3.1.3 and 3.1.4 only Netball NSW Affiliated Associations are eligible to enter the Junior State Titles conducted by Netball NSW.
- 3.1.2 Any grouping of Netball NSW Affiliated Associations can be admitted to enter the Junior State Titles as a combined Team subject to approval of the Competitions Manager in consultation with the Executive General Manager Community and Pathways.
- 3.1.3 Netball NSW may approve Teams to enter the Junior State Titles as an Invitational Team on an invitation basis. Invitational Teams will be charged a Netball NSW invitational fee of two hundred dollars (\$200.00) in addition to the Competition entry fee to enter the Competition.

- 3.1.4 Netball NSW may approve Teams that are not Affiliated Associations to enter the male divisions of Junior State Titles.
- 3.1.5 An Association, Grouping of Associations (per Clause 3.1.2) or Invitational Teams may only enter one Team per age category in the Junior State Titles.
- 3.1.6 All Players and Team Officials participating in the Competition must be a financial registered member of Netball NSW or any other Member Organisation prior to the commencement of the Competition.
- 3.1.7 The minimum age for any player to play at the Junior State Titles is turning 12 years old in the year of play.
- 3.1.8 The age of the players shall be determined by their ages as at December 31 in the year of play.
- 3.1.9 Where an age qualification applies, players are to play in their correct age group, unless special permission is granted. Any request for players to play in a higher age group than that for which they are eligible must be submitted on the designated form published on the Netball NSW website and submitted for approval by the Competitions Manager prior to the Competition.
- 3.1.10 Players will not be given approval to play in a lower age group to what they are eligible for.
- 3.1.11 The 13 years and 14 years age categories at Junior State Titles as listed in clause 3.2.1 (b) and 3.2.1 (c) are determined as a sporting activity for female players only.

3.2 Team Nomination & Entry

- 3.2.1 Associations may nominate teams to the following age categories of the Junior State Titles:
 - a) 12 and under
 - b) 13 and under
 - c) 14 and under
 - d) 12 and under Male
 - e) 14 and under Male
- 3.2.2 The closing date for the Junior State Titles will be notified on the relevant entry form and on the Netball NSW website.
- 3.2.3 The entry fee for the Junior State Titles will be notified to Affiliated Associations by Netball NSW before 30 November in the previous year.
- 3.2.4 All entries for the competition must be lodged as directed by Netball NSW and must be received by Netball NSW by the published time and date for close of entries. Late entries will only be accepted as detailed in clause 3.2.5 below.

- 3.2.5 Where an entry is not received by Netball NSW by the published closing time for entries, a late entry may be accepted. A late entry will only be considered if the late entry fee of five hundred dollars (\$500.00) has been paid and the late entry is received by Netball NSW in accordance with the late entry closing date, to be determined and communicated by Netball NSW.
- 3.2.6 Where an Entity withdraws a Team from the competition within three (3) weeks of the commencement of the Junior State Titles the offending Association will be fined five hundred dollars (\$500.00).
- 3.2.7 Associations are to register Teams as directed by Netball NSW, the entry will include details of a minimum of seven (7) and a maximum of twelve (12) players' names and must be received by the closing date for Junior State Titles.
- 3.2.8 Where a player's name appears on more than one Team entry form the player will be contacted by Netball NSW personnel prior to grading and the player must then immediately nominate the Association that they will be playing with.
- 3.2.9 Where a player's name is removed from a Team entry form by Netball NSW personnel prior to grading the Associations concerned will be advised accordingly. The Association will be given 48 hours from the time of advice to replace the player without penalty.
- 3.2.10 Team lists will be displayed on the Netball NSW website, one week prior to the commencement of the Competition and it is the Association's duty to check all players are listed and all details are correct.

3.3 Late Registrations

- 3.3.1 At no time is a Team permitted to have more than 12 players registered.
- 3.3.2 A maximum of four (4) players may be late registered in a Team. Late registrations and de-registrations will be accepted from one week prior to the commencement of the competition up until 8.00am on the first day of play where it can be lodged with Event control.
- 3.3.3 Following the close of entries, players listed on an original Team registration form are not permitted to de-register and re-register with another Team or another Association.
- 3.3.4 Late registration requests are to be completed and submitted as directed by Netball NSW, by an Association Official. The player must be a registered member of Netball NSW or any other Member Organisation.

3.4 Competition Grading

- 3.4.1 In 2024 grading of all age divisions will be undertaken having regard to the 2023 Junior State Titles Final Placings, as follows:
 - 2024 12U grading will be based on – 2023 12U final placing
 - 2024 13U grading will be based on – 2023 12U final placing
 - 2024 14U grading will be based on – 2023 13U final placing

- 3.4.2 Where divisions apply, at least the two bottom Teams (based on 2023 State Titles finishing position) will be relegated to the lower division and at least the two top Teams promoted to the next higher division. Placing for relegation and promotion shall be based on final point scores and where Teams finish on equal point scores then goal averages will be used to determine both promotion and relegation.
- 3.4.3 Team entries will be graded into divisions, being Championship Division, Division 2, Division 3 and Division 4 according to the number of Team entries received and taking into account clauses 3.4.3, 3.4.4, 3.4.5 and 3.4.6.
- 3.4.4 There will be 20 Teams in graded into Championship Division, except where more than 80 team entries are received in an age group, as per clause 3.4.4 (c).
- 3.4.5 While grading in 2024 will be based on the 2023 Final Placings, grading will be subject to any necessary changes Netball NSW consider appropriate. Considerations to grading may include:
- (a) Netball NSW will endeavour to divide Teams equally as far as possible to ensure equal number of Teams across all divisions.
 - (b) Netball NSW needs to take into consideration the number of entries received, new Team entries and non-returning Teams.
 - (c) Where more than 80 entries are received in an age group, 22 teams will be graded into the Championship Division for that age group.
- 3.4.6 Where a Team did not enter in the previous year's Junior State Titles, the Association can make a recommendation as to the preferred division for participation but the final grading decision will be made at the discretion of Netball NSW.
- 3.4.7 The grading of Male Divisions will be determined upon close of entries.
- 3.4.8 The final grading decision will be made at the discretion of Netball NSW.

3.5 Appeal on a Grading Decision

- 3.5.1 An Association may request a review of their provisional grading that has been actioned as per clause 3.4 of this policy, by submitting a request for an appeal including the grounds for a review to the Netball NSW Competition Manager within five (5) working days of the announcement of the provisional grading decision.
- 3.5.2 All applications for appeals must be presented by completing all questions on the Competitions Grading Appeals form, which is found on the Competitions General Information page of the Netball NSW website. The completed form must be submitted by the published closing date to the Competitions Manager at competitions@netballnsw.com.

- 3.5.3 The request for the appeal must state the grounds for review, or why the grading decision should be changed. It must specifically address issues regarding how the Team was evaluated under situations that put them at a distinct disadvantage to other Teams being evaluated.
- 3.5.4 The Competitions Manager will review all Appeals received. Where, in the sole opinion of the Competitions Manager, the Appeal satisfies all requirements for an Appeal per clause 3.5.3, an Appeals Panel will be appointed at the discretion of the Competitions Manager to adjudicate the Appeal. Appeals that are not deemed to have grounds for an appeal will be dismissed without a hearing at the sole discretion of the Competitions Manager.
- 3.5.5 It should be remembered that in general an appeal will only be considered if clause 3.4 of the Junior State Titles Competition Rules was not adhered to.
- 3.5.6 An Association can only lodge an appeal regarding a decision made which directly affects their Association. An Association cannot lodge and appeal for or on behalf of another Association or Associations. Any such appeal will be immediately dismissed without hearing.
- 3.5.7 The decision of the Netball NSW Appeals Panel is final and binding on all parties.

3.6 Invitational Teams

- 3.6.1 Invitational Teams approved to enter the Competition as per clause 3.1.3, may make a recommendation as to the preferred division for participation, however final grading will be at the discretion of Netball NSW.
- 3.6.2 A limit of 2 invitational Teams only will be accepted into each Age/Division. Invitational Teams will not be graded into Championship Division.
- 3.6.3 Invitational Teams may only enter one Team per age category in the Junior State Titles.
- 3.6.4 Points from games contested against Invitational Teams will be allocated as per clause 4.2.1. Invitational Teams will be removed from the final ladder placings and the ladder will be re-ordered as required.

3.7 Male Divisions

- 3.7.1 Netball NSW will determine the format and structure of the male divisions upon the close of entries to the Junior State Titles Competition.
- 3.7.2 Male divisions included in the Competition, will be held in accordance with these Rules subject to any necessary amendment in the absolute discretion of Netball NSW.

4 Competition Rules

4.1 General Rules

- 4.1.1 All Competition Matches will be conducted in accordance with the Rules of Netball, unless where otherwise stated within these competition rules.
- 4.1.2 All Teams will play each Team in their division during Junior State Titles, except when more than 22 Teams are graded in an age grouping in Division 2, 3, and 4.
- 4.1.3 Where there are more than 22 Teams graded in Division 2, 3 or 4 a maximum of 21 games in that age group will be played.
- 4.1.4 Playing times of matches is at the discretion of Netball NSW provided there is a minimum of one (1) minute half-time break and a minimum of two (2) minutes between games.
- 4.1.5 Substitution of players is permitted in accordance with The Rules of Netball.
- 4.1.6 Injury time may be taken according to the Rules of Netball, but no additional time shall be added to the match.
- 4.1.7 The umpire's whistle shall start and finish games on the indication from the central timing device.
- 4.1.8 A Team may claim a forfeit one (1) minute after the umpire's whistle to indicate commencement of play on the indication from the central timing device and if the opposing team does not have five (5) players in full uniform on court and ready to play. The umpires will sign the official score sheet attesting to the forfeit.
- 4.1.9 The winners of the Championship Division of each age division shall be declared the Junior State Title Champions.
- 4.1.10 There shall be no finals or joint placing. To determine the final individual placing point scores will be used and then if required to separate one or more Teams on the same points score goal averages will be used.
- 4.1.11 Any Team playing a non-registered player will be penalised as per clause 7.1.

4.2 Match Points

4.2.1 Points Table: Junior State Titles Points Table

Win	Loss	Draw	Forfeit	Bye	Abandoned
2	0	1	2	0	1*

4.2.2 Goal Average

- (a) If two or more Teams finish on equal points after the final round of matches, positions shall be decided on goal averages.

(b) The goal average for each team shall be decided as follows:

Total number of goals scored by the team, divided by the total number of goals scored against the Team, multiplied by 100 and divided by the actual number of matches played by the Team.

$$\text{i.e.} \quad \frac{\text{goals scored}}{\text{goals scored against}} \times \frac{100}{\text{matches played}}$$

The number of matches actually played includes a match a Team has forfeited, but does not include a match where the Team has received a forfeit.

- 4.2.3 Points from games contested against Invitational Teams will be allocated as per clause 4.2.1. Invitational Teams will be removed from the final ladder placings and the ladder will be re-ordered as required.

4.3 Cancellation

- 4.3.1 If, in the opinion of Netball NSW games are unable to be played due to an event which Netball NSW determines was beyond its control or beyond the control of either Team, (including, but not limited to, COVID-19, a lightning strike, power loss, wet weather that causes court or stadium damage), the following will occur:
- a) When matches are cancelled prior to commencement, in consultation with the Teams concerned Netball NSW may reschedule the matches. If matches are not rescheduled, all matches cancelled will be deemed to be a draw and each Team will receive (1) competition point each. No points will be awarded for teams having the Bye.
 - b) Where a match has commenced and is abandoned prior to half time the match will be deemed a draw and each team will be awarded one (1) point each.
 - c) Where the match had commenced and is abandoned at or after half time a win will be awarded to the Team with the highest score at the time in which the Match was stopped and the score at this time will be recorded.
- 4.3.2 The Netball NSW [Adverse Weather Conditions](#) Policy will be referred to making a decision on the continuation or suspension of any matches.

4.4 Player Minimum Requirements

- 4.4.1 All players in all age groups must play a minimum of 40% of the total number of available games over the Junior State Titles (**40% rule**). For the purposes of calculation of the '40% rule', two half games equals one full game
- 4.4.2 Where a player is unavailable for games for a medical reason, a medical certificate from a registered Medical practitioner or Physiotherapist or the on-site medic should be submitted with the 40% recording sheet, 40% of games will be determined from the games the player was available for.

ie: if a player is ruled out for 2 games of a total of the 19 games their Team is scheduled to play by a medical officer, then the 40% rule will be taken from only the 17 games that they are available to play.

- 4.4.3 Each Team will receive with their score sheets, a recording sheet to document the games each player has played over the three days of the Junior State Titles.

The recording sheet:

- a) Will include all registered players' names; and
- b) Provide for the documenting of the games each player has played; and.
- c) At the end of each day be signed by the Head Coach, the Team Manager and the Association Liaison Officer and submitted as directed by Netball NSW.

- 4.4.4 The penalty for a breach of the '40% rule' is disqualification from any placing and the Association responsible will be fined two thousand dollars (\$2,000.00). Where a Team is disqualified the team will have a 'DQ' designation next to the Team name on the competition ladder and will retain their competition points and corresponding ladder position for the purpose of grading in the following year Junior State Titles only.

- 4.4.5 When entries for the Junior State Titles are forwarded, a declaration of commitment of the '40% rule' for all players is to be signed by an Association Official. If the form is not received, Teams will not be accepted into the Junior State Titles Competition.

- 4.4.6 Any dispute in relation to the '40% rule' must, in the first instance, be referred by the party alleging a breach of the rule to the Player's nominated player's Association Liaison Officer for Junior State Titles. Suitable attempts to resolve the dispute should be made by both parties prior to completion of the competition

- 4.4.7 If any dispute in relation to the '40% rule' is unable to be resolved within 24 hours of being referred to the player's Association Liaison Officer, the dispute may then be referred by either party to Netball NSW. This must happen no later than 5pm on the Tuesday following the completion of Junior State Titles.

- 4.4.8 Any dispute in relation to the '40% rule' that is not referred to the player's Association Liaison Officer and/or Netball NSW within the time frames stipulated in clause 4.4.6 & 4.4.7 above will not be dealt with. At no time will any anonymous complaint in relation to the '40% rule' be dealt with or considered.

4.5 Scoresheets

- 4.5.1 The method of distribution of score sheets will be determined by Netball NSW.

- 4.5.2 Score sheets are to be returned to Event Control by the winning Team immediately after each match.

- 4.5.3 One (1) official from each Team is to sign the score sheet.

- 4.5.4 In circumstances where Team Officials of both Teams involved testify that the score sheet submitted to Netball NSW is incorrect and further they agree on the correct score then Netball NSW has the discretion to amend the official scores.

4.6 Awards

- 4.6.1 A trophy shall be presented to the winning and runner-up Association in each division.
- 4.6.2 Embroidered patches shall be awarded to the Manager, Coach, Assistant Coach, Primary Carer and players of the winning and runner up Teams in each division.

5 Officials

5.1 Team Officials

5.1.1 Coaches must:

- (a) Hold a current Working with Children Check which Associations are responsible for verifying.
- (b) Be a current registered financial member of Netball NSW or any other Member Organisation prior to the commencement of the Competition.
- (c) Head Coaches must hold a current **Development** Coaching Accreditation.
- (d) Assistant Coaches must hold a current **Foundation** Coaching Accreditation.

In **2024** the minimum Coaching Accreditation requirements for the Championship Division (Division 1) of Junior State Titles will be updated as follows:

- (a) Head Coaches must hold a current Intermediate Coaching Accreditation.
- (b) Assistant Coaches must hold a current Development Coaching Accreditation

5.1.2 Managers and Primary Carers must:

- (a) Hold a current Working with Children Check, which Associations are responsible for verifying.
- (b) Be a current registered financial member of Netball NSW or any other Member Organisation in the MyNetball database prior to the commencement of the Competition.

5.2 Umpires

5.2.1 Associations must provide umpires with their Teams as follows:

- (a) Where an Association enters two (2) Teams or more, one (1) non-playing badged umpire for each Team entered plus one additional non-playing badged umpire per Association, per day (i.e. an Association entering three (3) Teams must supply a minimum of four (4) umpires per day).

- (b) Where an Association has only entered one (1) Team, only one (1) non-playing badged umpire per day.
- 5.2.2 Umpires must at a minimum, hold a current **National C badge**. Umpires must have received the C badge prior to being included on the submission.
- 5.2.3 Nominated umpires entered into a Netball NSW competition must show as financial registered members of Netball NSW or any other Member Organisation prior to the commencement of that competition.
- 5.2.4 Nominated umpires may not play, coach or manage a Team during Junior State Titles.
- 5.2.5 Thirty (30) days prior to the competition, umpires names and current qualification are to be submitted by all Associations. Where umpires are not submitted by this date the Association will be fined five hundred (\$500.00) per umpire, per day that are below the Associations requirements.
- 5.2.6 Associations, withdrawing umpires after the 30 days submission date will be fined two hundred dollars (\$200.00) per umpire withdrawn unless a medical certificate is produced that certifies the umpire's unavailability due to illness or injury or other extenuating circumstances. If an umpire is not replaced with a badged umpire a further fine of two hundred dollars (\$200.00) is enforced.
- 5.2.7 Where an umpire withdraws on the day for other than medical reasons or other extenuating circumstances, or does not show, that Association will incur a fine of two hundred dollars (\$200.00) per allocation per day.
- 5.2.8 All umpires must be dressed in clothing that is distinct from the team's playing uniforms with suitable sports footwear. Umpires must wear a white top with a white or black skirt or shorts.

6 Photography and Videography

In addition to the clauses outlined below, the Netball NSW Photography policy will be referred to at the Competition.

- 6.1 Extended video footage should only be taken for training purposes.
- 6.2 All photographers and videographers should notify the opposing Team of their intention to photograph or video the match for consent.
- 6.3 All photographers and videographers taking photos on behalf of an Association must register with Event Control upon arrival at the Competition.
- 6.4 Photographers and Videographers may be asked to complete an accreditation form, and to wear a Netball NSW accredited photographer pass.
- 6.5 Photographers and Videographers should comply with any Courtside Equipment Guidelines published for the Competition.

7 Penalties

7.1 Except where these Competition rules provide that a specific penalty is to apply, any breach of these competition rules may result in any one or more of the following penalties being imposed on an Association by Netball NSW in its absolute discretion.

- (a) a fine of up to one thousand dollars (\$1000.00)
- (b) loss of competition points
