#### **Call for Nominations**

In accordance with The New South Wales Netball Association Limited (**Netball NSW**) Constitution (V1.14.2023) and the Netball NSW Election and Voting Policy, nominations are now invited from eligible individuals who wish to be considered for election as an Elected Director of Netball NSW with effect from the conclusion of the Netball NSW Annual General Meeting (**AGM**) to be held on **Saturday 16 March 2024**.

Terms used in this Election Notice bear the same meaning given to those terms in the Netball NSW Constitution or in the Netball NSW Election and Voting Policy (as the case may be), unless separately defined in this Election Notice or the context requires otherwise.

#### **Available Elected Director Positions**

In accordance with the Constitution, three (3) Elected Director positions are available to be filled at the 2024 AGM. The candidates elected to fill these positions will serve a term of **three (3) years**.

The terms of appointment of the following current Elected Directors expire at the AGM:

- Sallianne Faulkner eligible to re-nominate for the position of Elected Director in accordance with Clause 14.4 (b) of the Constitution.
- Louise Sullivan ineligible to re-nominate for the position of Elected Director in accordance with Clause 14.4 (d) of the Constitution.

In addition to the above, one (1) further Elected Director position is currently vacant.

#### **Eligible Candidates**

Nominations for the positions of three (3) Elected Directors are invited from eligible individuals who, in accordance with Clause 14.3 of the Constitution, meet the following qualifications of Directors:

- Must be a member of an Affiliate Member.
- Must be at least 18 years of age;
- Must not be a direct employee of Netball NSW;
- Cannot be an officer (as defined by the Act) or an Office Bearer of any Affiliate Member, Interested
  Member or Community Member or hold an equivalent position in circumstances where the Affiliate
  Member, Interested Member or Community Member is not a corporation; and
- Must not have been the CEO of the Company within the previous three years.

Netball NSW has a commitment to securing and maintaining a Board that has a balanced set of skills to represent its members and their interests. As an organisation, Netball NSW is committed to innovation, corporate governance and to be the benchmark in performance for state sporting bodies in Australia.

Candidates with skills and experience in the areas described in the Preferred Director Skills and Experience document set out in Appendix A to this Election Notice will be preferred and highly regarded.

#### **Nominations Process**

Nominations must be submitted in writing using the 2024 Director of Netball NSW Nomination Form set out in Appendix B of this Election Notice and must be signed by the nominee and the proposers of the nominee (who must be two (2) Voting Members of Netball NSW who are at least 18 years of age). All completed Nomination Forms must be accompanied by details of the nominee's relevant experience and qualifications as outlined in the Nomination Form, and a policy statement **not exceeding 750 words**.

Nominees for Elected Director positions must also complete, sign and submit the Consent to Act as a Director and Disclosure Form that forms part of the Nomination Form.

The **Nomination Form** and **Consent to Act as a Director and Disclosure Form** can also be downloaded from the Netball NSW website.

Nominations for the position of Elected Director open at 9:00am (AEDT) on Friday 19 January 2024 and close at 9:00am (AEDT) on Friday 2 February 2024. Completed and signed Nomination Forms (including the signed Consent to Act as a Director and Disclosure Form and any other accompanying documents) should be lodged with Netball NSW's Returning Officer (Stuart Corbishley) within the prescribed time period for lodgment by one of the following delivery methods:

Nominations must be received by the Returning Officer no later than 9:00am (AEDT) on Friday 2 February 2024. Please also note that any nominations received prior to the opening of the nomination period at 9:00am on Friday 19 January 2024 will be rejected.

Nominations can be withdrawn by nominees by notice in writing to the Returning Officer **by no later than** 9:00am (AEDT) on Monday 5 February 2024.

#### **Voting Instructions**

The election of Elected Directors will be conducted by the Returning Officer approved by the Netball NSW Board of Directors (Stuart Corbishley) using the Election Runner online voting system. The results will be declared at the AGM to be held in hybrid format at 9:00 am on **Saturday 16 March 2024 at Netball Central, 2 Olympic Blvd, Sydney Olympic Park.** 

Please note that voting instructions and access to Ballot materials for the election of Elected Directors will be sent via email to all nominated voting delegates, Netball NSW Life Members and Netball NSW Directors on Wednesday 28 February 2024. The ballot opens at 10:00am on Friday 1 March 2024, with voting closing at 5:00pm (AEDT) Friday 15 March 2024.

#### **Appendix A - Preferred Directors Skills and Experience**

### Preferred Directors Skills and Experience

As part of the Nominations Committee process, the Committee's role will include the task of identifying candidates to fill Director vacancies (including casual vacancies) and assessing all nominees for Director vacancies.

#### **Netball NSW Skills Matrix**

In accordance with Clause 14.5(c) of the Netball NSW Constitution, the Nominations Committee must utilise a Skills Matrix as part of its assessment of nominees for Director vacancies.

#### A Skills Matrix identifies:

- the skills, knowledge, experience and capabilities desired of the Board; and
- any gaps in skills or competencies that can be addressed in future director vacancies,

to enable the Board to meet both the current and future challenges of Netball NSW. The creation of a board Skills Matrix is an opportunity for considered reflection and productive discussion on how the board of directors is constituted currently and also how it believes it should best be constituted in the future to align with the strategic objectives of our business.

The Skills Matrix should always be tailored to the unique circumstances and requirements of the company concerned.

For Netball NSW, this process involved the current Netball NSW Directors firstly identifying the priority skill areas for the Board based on Netball NSW's strategic focus and other identified factors that should be included as part of the Skills Matrix to form part of the Nominations Committee's review for the 2024 Netball NSW Board Elections.

The current Netball NSW Directors then each individually completed a Board Expertise and Personal Attributes Self-Assessment. Each Director assessed up to their top five areas of expertise within the criteria provided and the consolidated Board Skills Matrix is set out at **Figure 1** of this Election Notice reproduced below.

The Board as a whole then undertook a review of the self-assessment results as part of an overall collaborative approach to assessing board skills and gaps for the upcoming 2024 Elected Director election round to provide that feedback to the Nominations Committee.

Figure 1 is therefore not intended to be read as an exhaustive list of potential skills and experience that a Director might bring for Netball NSW, but the ones your current Board determined to be the most important at the present time. Similarly, the number of Directors that hold a particular skill is not required to be balanced or equal as this will also depend on a number of factors.

After the completion of the Netball NSW Board Expertise and Personal Attributes Self-Assessment, and the feedback by the current Board for the 2024 Election round, the Nominations Committee has completed its oversight review of the skills audit, paying particular attention to the skills of the Directors coming to the end of their term. This review has highlighted the following areas of expertise as those of greatest priority for 2024 Elected Directors of Netball NSW to ensure an appropriate skills balance and succession planning for Board composition and renewal.

The five (5) identified preferred skills and experience set out below are in no particular order:

#### 1) Executive Management / Commercial Acumen

Experience at an Executive and/or Board level of a similar or larger sized organisation including the proven ability to;

- think strategically and identify and critically assess strategic opportunities and threats for Netball NSW;
   and
- appoint and evaluate the performance of the CEO and senior managers and a broad range of commercial/business expertise including business systems, practices and improvements.

#### 2) Risk

• Planning and implementing organisation-wide processes and procedures for the management of risk to the success or integrity of the organisation.

#### 3) Legal, Governance, and Government

- Proven experience in best practice corporate governance including the fiduciary and legislative frameworks that underpin Netball NSW particularly in the not-for-profit sporting context;
- Experience in the implementation and performance of governance, compliance and risk frameworks of a similar or larger sized organisation noting the ability to distinguish governance from Management and engagement with stakeholders as a governance representative.

• Legal background supported by governance or risk management qualifications from the Governance Institute of Australia or equivalent (preferred).

#### 4) Brand Marketing and Business Development

Experience and knowledge in one or more areas including brand awareness, marketing or business
development, including proven success in increasing the perceived value of a product line or brand over
time in the market and/or transforming customer experience, and driving product development and
innovation.

This may include, but is not limited to, relevant qualifications and/or experience as a marketing professional with demonstrated ability to focus on customer insights, data, predictive analysis, and measuring return on marketing investment.

#### 5) Ability to Lead Netball NSW

- The capacity, capability and interest to be Netball NSW President (and Chairperson of the Netball NSW Board);
- Broad netball industry knowledge, experience and passion;
- Proven leader in building and leveraging successful relationships with a wide variety of stakeholders and preferably existing high-level reputation and network in the netball community (Club/Association, statewide and/or nationally);
- Ability to effectively engage, communicate and influence, including to represent Netball NSW as a significant Member Organisation at the national level and in a variety of public forums, and to be the spokesperson for the views of the Board, in conjunction with the CEO, to Netball NSW's members, broader stakeholders and to the community;
- Strategic understanding of government and political processes;
- Leadership, people and organisation skills required of a Board Chair including (but not limited to)
  presiding over Board meetings, Annual General Meetings, Council Meetings; facilitating information flow
  to the Board and effective functioning of the Board; liaising and interfacing with the CEO as the primary
  contact between the Board and Management; reviewing performance of the CEO and overseeing and
  facilitating Board, Committee, Board member and CEO evaluation reviews and succession planning; and
- Ability to personally establish and model standards for Board behaviour and Netball NSW's Values and Behaviours; work with Board members to gain their personal commitment and energy to support Board goals; remove or reduce obstacles to Board effectiveness; coaches and develops Board members to top performance, encourages these team leadership behaviours organisation wide and is recognised as an outstanding leader.

#### **General Guiding Principles for Board Roles**

All candidates must have a genuine interest in, and a broad understanding of, Netball in Australia or the broader sporting industry, strong business acumen supported by demonstrable strategic aptitude, financial literacy, a sound understanding of good governance and well-developed communication skills.

In addition to the areas of skill or expertise noted, involvement in either high-performance (particularly experience as an athlete, coach, umpire and/or official), pathways development or deep understanding of and experience at the community level within a Netball environment will also be highly regarded.

In addition, candidates should possess the following personal attributes:

- A commitment to the highest standards of governance and integrity;
- Well-developed strategic thinking capabilities and ability to contribute to the effective decision making of the Board;
- Excellent communication skills with a collaborative approach;
- Preparedness to ask questions and challenge management and peer Directors in a constructive and appropriate way about key issues;
- Capacity to leverage professional networks to promote and grow Netball NSW by creating opportunities for both financial and other support;
- The ability to work as part of a team, and commit to acting with respect for Management, peer Directors and relevant organisational and Board processes;
- Demonstrated passion and time to make a genuine and active contribution to the Board; and
- Act in a manner consistent with a Director's role as custodian of the organisation and the game and appropriately represent Netball NSW. The Netball NSW Director Code of Conduct is available upon request.

At Netball NSW we are committed to creating a diverse and inclusive environment which reflects the community we serve. We actively promote gender diversity in our workplace, the employment of Aboriginal and Torres Strait Islander peoples, and the employment of people with a disability. We welcome and encourage applications from all people regardless of age, gender, ethnicity, cultural background or sexual orientation.

We encourage interest from candidates from regional areas of New South Wales.

#### **Eligibility**

Pursuant to Clause 14.5(a) of the Netball NSW Constitution the Nominations Committee has the power to determine that a nomination is unsuitable for further consideration by the Company, the Directors or the Members (as applicable) but only if this decision is unanimous.

As set out in clause 5.3(d) of the Nominations Committee's Terms of Reference, a nomination will be eligible where it meets the skill, expertise and personal attribute sets required and identified in the Netball NSW Board Skills Matrix. Where a nomination fails to satisfy the criteria, the Nominations Committee may determine that the proposed candidate is ineligible to stand for election to the Netball NSW Board in the year that the proposed candidate has nominated for the position.

#### **Board Requirements**

For 2024 it should be noted that Board meetings are scheduled for approximately every 6 weeks and additionally Directors will be appointed to one or more Board Committees which meet as required, being:

- Audit and Risk Committee;
- Governance Committee;
- People and Culture Committee;
- Nominations Committee;
- Other committees or awards panels as required.

Dates for conflict checking are available on request.

All nominations will be assessed in accordance with Clause 14.5 of the Netball NSW Constitution.
