Council Meeting of The New South Wales Netball Association Limited held on **Saturday 4 November 2023** at the Waratah Room, Netball Central, 2 Olympic Boulevard, Sydney Olympic Park and via Zoom video conference.

The meeting commenced at 9.02am

3.2 Finance Report

3.2.1 Financial Report: 8 months ended 31 August 2023

The Financial Report for the period ending 31 August 2023 distributed prior to the meeting was taken as read and **noted**, with the following **noted** from the presentation given by Tim Brown (CFO):

- Netball NSW's current net asset position as at 31 August 2023 is \$24.1m (with a projected net asset position of \$22m as at 31 December 2023). Netball NSW's 2023 full year forecast EBITDA is +\$132k although, excluding grant income, the full year forecast EBITDA is circa -\$90k (a negative projected variance to budget of -\$27k). As at 30 September 2023, Netball NSW's 2023 full year forecast (excluding grant income) is -\$63k.
- This EBITDA position has been negatively impacted by slightly lower capitation revenue (-\$205k), higher NetSetGo costs (-\$93k) and -\$55k in net other costs, but favourably impacted by insurance rebates and net commercial upside.





• On Netball NSW's balance sheet, cash reserves are projected to decrease to \$2,487k as at 31 December 2023 against a cash balance of \$2,733k as at 31 December 2022. As at 30 September 2023, Netball NSW's cash balance is anticipated to be \$2.4m as at 31 December 2023.

3.2.2 Budget for the Financial Year ending 2024

It was **noted** from the presentation given by Tim Brown (CFO) that the Draft Budget for the Financial Year ending 2024 was well advanced, with a focus being placed on returning the business to a breakeven result whilst Netball NSW looks to ensure sustainable financial growth for reinvestment into the game. The Draft FY24 Budget will be presented to the Board for approval at the 29 November 2023 Board meeting. Netball NSW is targeting revenue uplifts of 6-7% in the Draft FY24 Budget to support Netball NSW's Associations and communities and to be less reliant on capitation revenue (which is forecast to represent 39.7% of budgeted revenue), with a staffing model aligned to driving that revenue growth whilst continuing to support Associations, Clubs and communities.

4.3 Finance Report

4.3.1 Overview

NNSW provides this financial update to Affiliated Associations prior to the Council Meeting.

This update comprises the latest Financial Report 2024 as at 31st January 2024 as well as an update on the Budget 2024. A financial presentation with additional relevant information will be presented at the Council Meeting.

4.3.2 Financial Report: (for the period ending 31 January 2024)

The finance report for the period ending 31 January 2024 is attached, pages 23 - 24.

The Financial Report for January 2024 for NNSW shows a net asset position of \$22.9m (including fixed assets with a book value of \$22.6m which is predominantly Netball Central).

NNSW full year forecast for 2024 as at 31st January 2024 is for a breakeven position (before interest & other income, depreciation and amortisation "EBITDA") which is consistent with the Board approved budget for 2024 set at a breakeven position.

The January YTD EBITDA (before extraordinary items) is \$0.905m, which is consistent with budget. This compares favourably to the full year forecasted breakeven EBITDA. It is normal for NNSW to report a high EBITDA at the commencement of the financial year which results from very strong early income flows on Season 2024 registrations & SSN memberships. This is offset later in the year as costs are more evenly spread across the year.





As at 31 January 2024, player registrations (Play HQ platform) totalled 36,009 (\$2.6m) vs. 31 Jan 23: 34,501 (\$2.3m). As at the most recent reporting date 19th February 2024 player registrations are at 60,331 (\$4.6m), this compares to 56,832 (\$4.3m) at 19 February 2023. We therefore, at this stage, project player registrations for the full year to come in close to the budget set at 119,800. This compares favourably to the final total registrations of 111,007 in 2023.

SSN clubs Membership (Swifts and Giants) totalled circa \$1.29m (6,251) as at 31st January 2024 compared to \$927k (5,651) at the same time in 2023. The full year Membership target is \$1,199k (86% sales achieved as at 31 January 2024) and management are highly focussed on achieving this. Note as at the date of the report, ticket on-sale is approaching and hence a further update on ticket sales will be provided at the Council Meeting.

Commercial contracted sales for 2024 are sitting at \$3.7m (85% of budgeted target \$4.4m) as at 31st January 2024. At this stage Management has confidence in achieving the 2024 budgeted number.

On the balance sheet, at 31st January 2024 the cash balance was \$2.1m compared to the year-end balance (31st December 2023) of \$2.6m. As at the date of this report (20 February 2023) cash is sitting at circa \$4.02m. We expect a higher cash balance in Q1 of each year, attaining to the nature of the business and high volume of registrations this time of the year. Cash at the end of the year forecasted to be circa \$2.7m.

A further financial updated will be provided to Council members closer to the Council meeting.

5. Application for Affiliate Membership

Junee & District Netball Association (*Junee Netball*) have submitted an application to become a Full Affiliate Member of NNSW under Clause 9.3 of the Constitution. The affiliation application submitted by Junee Netball on 3 October 2023 is attached on pages 27 to 28 of this Notice of Council Meeting.

As required by clause 9.3 of the Constitution, the information that must be included in an affiliation application is set out in clause 3 of the Affiliation and Membership Policy.

Following management's and the Board's review of Junee Netball's affiliation application, further information and clarifications were sought from Junee Netball to address deficiencies identified in the information provided in its affiliation application. A summary of the further responses provided by Junee Netball on 3 January 2024 to NNSW's requests for further information and clarifications are set out below:

- **Organisational growth plan (if any);** [Junee Netball response not provided.]
- **Facilities and infrastructure plan (if any);** [Junee Netball response We have two indoor courts (through the Recreation Centre) which have a seating capacity of approximately 150 people.]
- Governance structure including whether Junee Netball is, or intends to become an Incorporated Association; [Junee Netball response We have been an "incorporated club" for 3 years now.]
- The proposed structure of the organisation in terms of membership and clubs; [Junee Netball response not provided.]





- How Junee Netball intends to grow grassroots netball in the region, including any programs that it intends to run; [Junee Netball response We intend to grow grass roots netball by running programs such as Net Set Go and School programs.]
- How Junee Netball intends to facilitate umpire and coach development; [Junee Netball response -In relation to Coaching and Umpiring development. We constantly encourage all our umpires and coaching staff to further develop themselves Wherein we also assist in subsidizing fees. We currently have 4 badged umpires, 4 training umpires, 3 Development Accredited Coaches and 4 Foundation Accredited Coaches.
- An indication of where participants and potential members would be coming from; [Junee Netball response We are hoping to reach areas which encompass Yethela, Harefield, Sebastopol, Junee, Old Junee, Junee Reefs, Illabo, Bethungra and Eurongilly.
- Any consultation that has occurred with neighbouring Associations; [Junee Netball response We have raised the possibility of Junee being affiliated with 3 of our closest associations being Coolamon, Temora and Wagga Wagga.

Having further considered Junee Netball's affiliation application and responses to NNSW's further requests for information and clarifications, at its 13 February 2024 Board meeting, the Board and resolved to present the affiliation application to Council in accordance with the requirements of clause 9.3 of the Constitution but does not support the affiliation application and does not recommend that Members approve the affiliation application at this time on the grounds that, at this stage, insufficient information was has been provided to support affiliation.

Before opening up the voting on this resolution, Members will be invited to speak to the motion.

To consider, and if thought fit, to pass the following resolution as an ordinary resolution:

THAT, in accordance with the requirements of clause 9.3 of the Constitution, the application of Junee & District Netball Association to become an Affiliate Member is approved.

However, the Board felt it was appropriate to commence a discussion with Council on the matters raised in the January 2024 Notice of Motion.

At the 16 March 2024 Council Meeting, the Chair will facilitate a discussion which addresses the following key matters:

- summary of current process for receiving Life Membership;
- role and purpose of the Recognition Reference Panel; and

Taking into account discussions related to the January 2024 Notice of Motion, the Board also felt it appropriate to hold a discussion at the Council Meeting on the following matters:

- the legal and constitutional requirements that must be followed by Members to submit a valid member resolution for inclusion in the business of a AGM or Council Meeting and in the Notice for that meeting;
- the legal and constitutional obligations of the Board in relation to the matters that are included in the business of the AGM or Council meeting and in the Notice of that meeting; and
- Netball NSW's preferred consultation and feedback process for Member or Board-led Constitutional or other governance improvements to enable all Members to have the





opportunity to understand the nature and reasoning for any reforms for the future benefit of the sport prior to the formal meeting where they will be voted upon

Please note that whilst Netball NSW respects that there is no legal requirement to implement a consultation and feedback process prior to presenting proposed constitutional changes to Council to vote upon, Netball NSW would prefer to discuss with our Members at the Council meeting why it is our preferred approach to build trust and transparency in the context of future governance reform.
