Council Meeting of The New South Wales Netball Association Limited held on **Saturday 16 March 2024** at Netball Central, 2 Olympic Boulevard, Sydney Olympic Park and via Zoom video conference.

The meeting commenced at 10.15am

3.2 Presentation: Community and Pathways

The presentation given by Tim Fava (EGM - Community & Pathways) in relation to participation data, PlayHQ developments, competitions, Netball in Schools programs, State Teams performance and pathways, facilities and infrastructure opportunities, support provided to Associations and key growth and innovation initiatives and plans was **noted**.

ACTION: Management to liaise with Associations requiring additional assistance to meet coaching accreditation requirements for State Titles and to provide information and support to Associations in relation to grant funding program opportunities, including the Local Heros Grant and other funding opportunities.

3.3 Finance Report

3.3.1 Financial Report for the period ending 31 January 2024

The Financial Report for the period ending 31 January 2024 distributed prior to the meeting was taken as read and **noted**, with the following **noted** from the presentation given by Manuel Vlandis (CFO):

- Netball NSW's net asset position as at 31 January 2024 is \$22.9m and Netball NSW's full year forecast for 2024 as at 31 January 2024 is for a breakeven EBITDA, which is consistent with the Board approved budget for 2024, which was set at a breakeven position.
- As at 31 January 2024, player registrations totalled 36,009 (\$2.6m), compared with 34,501 (\$2.3m) at the same time in 2023. As at 19 February 2024, this total is 60,331 (\$4.6m), which compares with 56,832 (\$4.3m) at the same time in 2023. Management expects that player registrations for the full year will be close to budget (119,800). This compares favourably to final total registrations of 111,007 in 2023.
- As at 31 January 2024, SSN club memberships (NSW Swifts and GIANTS Netball) totalled 6,251 (\$1.29m), compared with 5,651 (\$927k) at the same time in 2023. This represents 86% of the membership target of \$1.199m.
- As at 31 January 2024, \$3.7m in commercial revenues have been contracted, representing 85% of the budgeted target of \$4.4m.
- As at 31 January 2024, the cash balance was \$2.1m, compared with the year-end balance of \$2.6m as at 31 December 2023. As at 20 February 2024, the cash balance is \$4.02m. The forecast cash balance as at 31 December 2024 is \$2.7m.

ACTION: No action required.

3.3.2 Budget for the Financial Year ending 2025

Manuel Vlandis' presentation on the Draft Budget for the Financial Year ending 2025 (which has a breakeven EBITDA) was **noted**, with management to target revenue uplifts (with an aligned staffing model), whilst providing additional support to associations, clubs and communities and driving a closer connection to Netball NSW's SSN clubs.





ACTION: Management to consider further the prioritisation of netball court bookings at Netball Central.

3.4 CEO's Operational Report

The presentation given by the CEO regarding Netball NSW's key areas of focus and strategic priorities for 2024, 2024 performance measures and 2024 challenges and opportunities was **noted.**

5.4 Discussion: Notices of Motion to amend the Constitution and the award of Life Membership

The President provided a summary in relation to: (1) the Notice of Motion to amend the Life Membership provisions of the Constitution submitted by two Life Members on 18 January 2024; (2) the reasons why it was not possible for that motion to be presented to Members at the meeting (and the legal and constitutional requirements that need to be met); (3) the current process for the award of Life Membership; (4) the role and purpose of the Recognition Reference Panel; and (5) Netball NSW's preferred consultation and feedback process for constitutional amendments and other governance reforms.

The President then invited comments and questions from Members, with contributions made by Anne Doring OAM, Maureen Boyle OAM, Rodney Watson OAM, Vincent De Luca, Clare McCabe, Wendy Archer AM, Lynn Quinn OAM and Jason Baker in subsequent discussions.

ACTION: Governance Committee to consider the processes for nominating Life Members and submitting Member Notices of Motion and provide recommendations to the Board (including with respect to any recommended constitutional changes), with the Board to then undertake appropriate consultations with Members and present any recommended constitutional changes for approval at the next Council meeting.
